## Your Giving Truly Makes a Difference

Mr. and Mrs. Simmons came to know AHIF in 1989 when their four-year old son sustained a traumatic brain injury after having a seizure, falling and hitting his head in their kitchen. Since that time, in addition to direct support services, AHIF has provided respite care to the Simmons where a home health worker comes to their home to take care of their son for a short time. In May 2015, Mrs. Simmons requested such a respite care visit so that she could take her husband to a doctor's appointment in Birmingham.

The following day, Mr. Simmons was in a terrible car accident himself, and remains in critical condition at a Mobile hospital. Mrs. Simmons contacted AHIF with the most tragic of dilemmas. Her son does not handle staying away from home very well, and yet she wants to be with her husband as much

as possible in Mobile. Mrs. Simmons acknowledged that she had used up her respite voucher for the year, but wanted to know if there was anything that could be done. Contributions to AHIF make respite care possible, and AHIF was able to offer another voucher so that Mrs. Simmons could be with her husband and know that her son was also in good hands. When AHIF employee Janice Waters, who coordinates the respite care program, called Mrs. Simmons to let her know, Mrs. Simmons immediately began crying and thanking Jesus. She said that words could not express how grateful she is for the respite care hours. AHIF similarly cannot express how grateful we are to those who generously support our programs so that we can help individuals like the Simmons family in their time of need. Thank you.

#### AHIF graduates its first Matter of Balance class

For AHIF Program Director Holli Driver, teaching the Matter of Balance class is so much more than her job. On July 2014, her grandfather fell on his porch, hit his head and had a seizure. He went to a local hospital, was transferred to UAB, and then to HealthSouth Lakeshore for rehabilitation. Thankfully, her grandfather recovered from his fall, but the entire incident left her thinking about ways to prevent falls and how AHIF could assist Alabama's aging

population.

AHIF recently learned of a fall prevention program for seniors called Matter of Balance. Through a grant from the Lucille Beeson Trust, Holli Driver was trained to implement this program locally.

AHIF graduated its first class on August 26, 2015. The class consisted of individuals ages 67-90. The class met twice a week for two hours at Hunter Street

Baptist Church. Individuals learned about managing falls, concerns and fears about falls, "fall-ty behaviors" in the home and completed a home safety checklist. AHIF is excited to be a partner in helping spread the word on fall prevention.


